**Admission:** Spectators \$5.00 at the door.

**Weigh-Ins:** Friday 4/26/24 from 6:00PM-8:00PM, Saturday 7:00AM-8:30AM. If wrestlers do not make weight, there will be a \$10.00 move up fee.

**Entry Fee:** \$25.00 per wrestler. Pay at weigh-Ins or QR code.

**RULES:** Matches are three 1 minute periods for youth and three 1 ½ minute periods middle school and high school divisions & Scholastic Rules Apply with Overtime. We reserve the right to combine classes. NO WEIGHT WILL BE GIVEN. Start times for divisions could be adjusted depending on the flow of the tournament. Wrestling is set to start at 9:00-9:30 AM. Will run three to four mats for the tournament depending on registrations.

**AWARDS:** 1st – 3rd Place Individual will receive medals and 4th-6<sup>th</sup> will receive ribbons..

**High School Girls Division-** There will be a separate high school girls division. Girls can wrestle both boys' and girls' division.
